INGEO MORE THAN DOUBLES TRANSACTION VOLUMES FROM Q4 2008 TO Q1 2009

Despite the economic downturn and dismal reports in the housing market, Ingeo finished the first quarter of 2009 with extraordinary numbers. The total of transactions recorded by the company in the first three months of this year were 209% of the total recorded during the last quarter of 2008. "We're very pleased with our performance during the first three months of this year," said Karl Klessig, Ingeo's CEO. "We had a drop in volumes during the fourth quarter, which was expected given market projections and industry forecasts. But we redoubled our efforts to meet and exceed our targets in the new year."

The company's determination to deliver outstanding results has paid off. "We have seen our daily volume rate rise substantially month by month during this quarter," Klessig said. "Our growth from January to February was more than 166% and the March numbers are 193% of the January figures."

The company also expanded its county network during the first quarter, building from 261 counties at the end of the year to 276 at the end of this first quarter. "We have eight more counties scheduled to go live in the next 30 days and another 20 by the end of the second quarter," Klessig explained.

"We've also increased the number of partners we integrate with," Klessig explained, "growing to 30 technology partners on the county side and 24 business partners on the submitter side." All of these factors contribute to Ingeo's fast-paced growth and the company's leadership position in the industry.

INGEO RECORDS FIRST ELECTRONIC DOCUMENT IN MIAMI-DADE COUNTY

Ingeo recently processed the first electronic mortgage document in the history of Miami-Dade County, Florida. This is the most populated county in Florida with nearly 2-1/2 million people, according to U.S. Census Department estimates for 2008.

"Ingeo now has its electronic document recording solution in eight of the ten most populated counties in Florida, covering nearly 58% of the state's population," said Karl Klessig, Ingeo's CEO. "Currently, we have a total of 11 Florida counties in our network with nine more scheduled for the near future. This means that soon more than 78% of Florida's population will benefit from the speed, efficiency and cost savings of Ingeo's e-recording system."



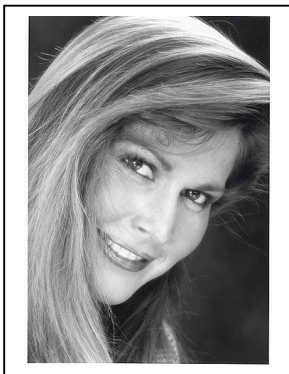

INGEO AND RECORDFUSION ANNOUNCE NEW INTEGRATION PARTNERSHIP



Ingeo has formed an integration partnership with RecordFusion, a provider of end-to-end document management solutions with headquarters in New Castle, Pennsylvania. This alliance promises to increase Ingeo’s county footprint in Pennsylvania, New Mexico, Colorado, Michigan and New Jersey.

“In RecordFusion counties, Ingeo supplies the submission and management side of the electronic document recording process,” said Karl Klessig, Ingeo’s CEO. “But in most other venues, we provide a total services solution.” Ingeo’s ability to integrate and adapt to almost any electronic recording configuration and requirement is a unique capability that has allowed Ingeo to rapidly expand electronic recording to more jurisdictions.

Currently Ingeo has 276 counties in its network. The company works with nearly all the major county recording system vendors, and now has 30 technology partners. Ingeo’s Electronic Document Recording System reduces processing time and costs while improving data accuracy. In any given month Ingeo processes more documents than all other recording organizations combined.
